## **Background and Sufficiency Duties**

The Childcare Act (2006) requires local authorities in England to ensure a sufficiency of childcare for working parents, parents studying or training, and for disabled children. Childcare sufficiency relates to the provision of registered childcare for children aged 0-14 years old, and up to 18 years old for disabled children and children with additional needs.

The duties in the Act (section 6) require local authorities to shape and support the development of childcare in their area in order to make it flexible, sustainable, and responsive to the needs of the community. This role is described as a market management function, supporting the sector to meet the needs of parents, children and young people, and stakeholders.

The requirement to undertake a Childcare Sufficiency Assessment (Section 11 of the Act) was repealed in the Children and Families Act (2014) however the Sufficiency Duty remains in statute. Local Authorities are required to report annually to elect council members on how they are meeting their duty to secure sufficient childcare. The annual report should demonstrate an understanding of the local early years and childcare market as a pre-requisite to ensuring, 'as far as is reasonably practicable', the childcare sufficiency duty is being met, that early years provision is being secured free of charge, and that information is available to support parents, carers, and providers.

#### About Telford & Wrekin



The population of Telford and Wrekin continues to grow at above national rates. The population is also ageing at a faster rate than that seen nationally, with the growth seen in the number of over-65 residents between 2011 and 2021 one of the biggest in England. As the borough grows, it is also becoming increasingly diverse, particularly amongst our younger residents.

Some neighbourhoods and communities in the Borough are among the most deprived areas nationally, with other communities amongst the more affluent in England. There are notable inequalities in the borough which are affecting outcomes for residents, and overall health in the borough is below average."

NHS birth data and ONS data has been used to predict the number of children per term who fall in age ranges potentially eligible for funding during that term.

## Early Years Entitlements

All Early Years funding entitlements take effect from the start of term following the child reaching the relevant age. Funded hours per week (15 or 30) are applied term time (38 funded weeks) but can be stretched if the setting offers flexible provision.

#### 9 months old

Families eligible for funding through the Working Families offer have been able to access 15 funded hours per week from Autumn 2024, increasing to 30 funded hours per week from Autumn 2025. Families apply through Childcare Choices and must reconfirm eligibility every three months.

#### 2 years old

Families eligible for funding through the Working Families offer have been able to access 15 funded hours per week from Summer 2024, increasing to 30 funded hours per week from Autumn 2025. Families apply through Childcare Choices and must reconfirm eligibility every three months.

Families eligible for funding through Talking 2s (low income, non-working and special circumstance) are able to access 15 funded hours per week. Families apply through the local authority. Some families may be eligible for both types of funding, however they cannot be combined.

#### 3 and 4 year olds

All 3 and 4 year olds are eligible for the universal 15 funded hours per week, from the start of term following their 3<sup>rd</sup> birthday. This funding does not need to be applied for.

Families eligible for funding through the Working Families offer can access an additional 15 funded hours per week. Families apply through Childcare Choices and must reconfirm eligibility every three months.

## Early Years Spring 25 Sufficiency Survey

During Spring 2025, all early years providers in Telford & Wrekin were asked to complete a survey around sufficiency and planning. The response rate was 97%.

For consistency, the survey defined a place as 30 hours. This will also assist in planning ahead for the expanded rollout.

For consistency, a specific week was set to collect data, and a specific date for a headcount. This aimed to account for children who may split their hours between settings.

## Types of provision and available places

In Telford & Wrekin there are 152 Early Years settings; 52 PVI settings, 33 school based settings, and 67 childminders (65 Ofsted registered and 2 Tiney Childminder Agency registered).



The Early Years & Childcare team supports all settings within the local authority, and targeted support is provided should Ofsted grade a setting less than good. A range of CPD opportunities are offered each term to develop practice and support practitioner knowledge.

## Provider views on delivering expanded entitlements

Providers were given a free text field to mention any implications or challenges regarding the increase to 30 funded hours for Working Families funded 2 year olds and under in September 2025. Of those who offer places for 2 years and under, the following themes were identified. 6 settings that only offer places for children aged 3 and up also identified concerns about lack of spaces or being able to offer parents their preferred hours.

#### Grants

The Department for Education predicted that in September 2025, Telford & Wrekin will need an additional 452 places (or 18% more childcare places) to meet the demand of the extended offers.


To meet this demand, three new settings and one childminder have opened in Telford & Wrekin. This increased places by 163: 31 under 2s places, 49 2 year old places and 83 3 and 4 year old places. Through careful distribution of capital funding, a further 253 new places have been created in readiness for September 2025 if staffing levels permit. Of these places, 59 are under 2s places, 153 are 2 year old places, and 41 are 3 and 4 year old places. A small amount of capital funding is still available to further develop capacity.

## Recruitment support

22% of settings responded that they were experiencing issues relating to staffing.

Of settings reporting staffing related issues, 75% were PVI, 13% were childminders and 13% were school based settings.

Of settings reporting staffing related issues, 94% were around the recruitment of suitably qualified staff. Settings were asked to identify the qualifications needed.



Staffing in early years settings is a national issue, see <u>Maintaining quality early years</u> provision in the face of workforce challenges – Ofsted: early years.

To support recruitment, the Early Years & Childcare Team attend a variety of events such as jobs fairs, career advice days and work closely with a range of local training providers to promote working in early years as a professional career pathway. Settings are supported to share vacancies by the local authority via a range of routes.

Telford & Wrekin were recently part of the DfE Early years financial incentives beta (live test) <u>Early years financial incentives private beta (live test)</u> where 20 practitioners were successfully recruited.

## Anticipated future demand

#### 9 month olds

As Autumn 2024 (last term) was the first term of funding for 9 month old places, historical take up data is not available to use in predicting future demand. Therefore, as the eligibility criteria are the same, the take up percentage for Working Families funded hours for 3 and 4 year olds has been used in this report. As more data is collected, this percentage can be further refined to estimate projected demand.

#### 2 year olds

Talking 2s take up has been calculated using historic year on year take up data.

As Summer 2024 was the first term of Working Families funding for two year olds, sufficiency historical take up data is not available to use in predicting further demand. Therefore, as the eligibility criteria are the same, the take up percentage for Working Families funded hours for 3 and 4 year olds has been used in this report. As more data is collected, this can be further refined to estimate projected demand.



## Waiting lists

As children are on waiting lists even though there are vacancies, further data was collected around the reasons for families joining a waiting list. 13% of families were on a waiting list because they were unable to find a place, and 22% of families were on a waiting list to accommodate their preferred days or hours. 12% already had a place elsewhere but wanted to change according to preference, and 22% were on a waiting list in advance of the child becoming old enough to take up the place.

## Sufficiency assessments by school place planning area

The Joint Strategic Needs Assessment (JSNA) 2024 states: "some neighbourhoods and communities in the Borough are among the most deprived areas nationally, with other communities amongst the more affluent in England. There are notable inequalities in the borough".

In view of this, historical funding claim data has been used to individually assess take up of different types of funding within each school place planning area (see page 4). Some areas such as Newport and North East Central have a Working Families funding take up higher than the borough average. South East and South Queensway have below borough average rates of Working Families funding, but the highest percentage of Talking 2s funding. This awareness will become increasingly useful in predicting demand as the Working Families funded hours entitlement will be double that of universal and Talking 2s funding. (This has been considered in the estimates of future funded children.)

To assess predicted growth to meet expanded entitlements, a red/green colour coding system has been used, with red indicating an expected decrease in capacity, and green indicating an expected increase. In some instances, a high percentage increase or decrease will show for childminders. For example, in North East Central, childminder capacity for 2 year olds is predicted to drop from 10 places to 6 places. This drop of 4 places calculates as a 40% decrease.

Whilst place planning areas serve as a useful guide, we are aware that families also travel outside of their home place planning area for childcare. This will have an impact on the reported capacities and vacancies compared to the number of eligible children identified.


## Wraparound Provision

In September 2024, the government launched a national expansion to the wraparound programme for primary aged children.
