- 4. Any persons wishing to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirements of the Act or of any instrument made under the Act have not been complied with, that person may within 6 weeks from the date on which the Order is made, apply for that purpose to the High Court.
