**TWC/2023/0080 & TWC/2023/0081** – Cheswell Manor, Cheswell, Newport – Conversion of two storey hay barn into entertainment/leisure space including reintroducing openings, additional windows, a kitchenette, plant room, shower room and wc and the single storey stable into a spa barn with sauna, changing facilities, resistance swimming pool and replacement roofs (Full Planning Application & Listed Building Application)

**TWC/2023/0082 & TWC/2023/0083** – Flat 9, The Wharfage, Ironbridge – Change of use of 1no flat to additional accommodation for the White Harte Public House with insertion of 1no. new door opening, bricking off of 1no door opening, rendering of side elevation, internal layout changes and 5no replacement windows (Full Planning Application & Listed Building Application)

**TWC/2023/0104 & TWC/2023/0105** – Belmont House, Belmont Road, Ironbridge – Creation of new access from first floor main bedroom into the second bedroom which will then be split into an en-suite and laundry, internal reconfiguration of second floor 2no. bedrooms, bathroom and landing area to improve the circulation space and the installation of 3no. conservation roof lights (Full Planning Application & Listed Building Application)

**TWC/2023/0106** – 44 Station Road, Madeley – Erection of a single storey side extension to existing garage and conversion into an annexe for ancillary use

**TWC/2023/0107** – 16 Severnside, Ironbridge – Removal of 10no. existing timber windows and 3no. timber doors and replace with 10no. new double glazed timber windows and 3no. new timber doors

**TWC/2023/0113** – Longswood Farm, Longswood – Change of roof materials on main roof (Retrospective)
