NOTICE IS GIVEN that Tibberton & Cherrington Parish Council has prepared a neighbourhood development plan for the Tibberton and Cherrington area (The Plan Area is clearly described in the Plan.).

The Plan has been developed by the Parish Council to establish a long term view for the Tibberton and Cherrington area and help deliver the local community's aspirations and needs for the plan period 2020 – 2031. The plan sets out a number of key objectives and planning policies which the Parish Council wishes to be used to help determine planning applications in the Tibberton and Cherrington areas. The Tibberton and Cherrington Parish Neighbourhood Plan proposal is being referred to an independent person for independent examination.
