This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.	None
<b>Contracts</b> Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest) and the Council — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.	No direct contract with the Council but am an Agent for Applicants who engage the services of the Planning and Building Control Depts. (Declaration made with an abundance of caution).
