Key Points from discussion on the Learning Disability Engagement:






Leon – if there are people who don't feel safe then should we find a way of making me feel safe?

Other areas to consider:




- Make sure support plans include seeing friends
- Consider walking groups

Key Points from discussion on the Training for paid carers:





Leon – in some places things are shabby, and they don't have appropriate training to support people with learning disabilities - understanding and knowledge of learning disabilities and knowing what's out there.



Parent and carers – understanding of behaviours and supporting people's mental health are lacking

Other areas to consider:



A standard across care providers about what they need to do around training, specifically around learning disabilities. This needs to be built into the framework. Involving experts by experience in recruitment and training Regular feedback on providers is needed to hold them to account
