NOTICE IS GIVEN that Lilleshall Parish Council has prepared a Neighbourhood Plan for the Lilleshall Parish Council administrative area (the plan area is clearly described in the Plan) and representations are now invited on the Lilleshall Parish Neighbourhood Plan.

The Lilleshall Parish Neighbourhood Plan has been developed by the Parish Council to establish a long term view for the Lilleshall area and help deliver the local community's aspirations and needs for the plan period 2017 - 2031. The Lilleshall Parish Neighbourhood Plan sets out a number of key objectives and planning policies which the Lilleshall Parish Council wishes to be used to help determine planning applications in the Lilleshall area. The Lilleshall Parish Neighbourhood Plan proposal is being referred to an independent person for independent examination.
