# **Executive summary**

## Purpose of this report

This report has been produced for the purpose of providing an update to the detailed water cycle study as submitted to Telford & Wrekin Council (TWC) in November 2014. Since the previous report was submitted the Council has revised its housing target. The purpose of this report is to support TWC to maintain a robust evidence on the run up to submission of its Local Plan. Specifically this report provides a refresh of the evidence base and a revised set of outputs and recommendations. This report updates relevant sections of the original Final Report and does not replace that original report. This update should be read in conjunction with the original.

## Scope of Update

## 1.1 Revised housing and employment figures

As part of compiling the next Local Plan (Shaping Places) Telford & Wrekin Council (TWC) commissioned Amec Foster Wheeler to produce a Water Cycle Study during 2014. The housing data used as part of that study was based upon a target of 20,000 homes to be built over the duration of the Local Plan (20 years). At that time approximately 12,000 new homes across 422 sites had already been committed (i.e. granted planning permission but had not commenced construction) and a further 8000 homes were allocated.

Since that original study the housing and employment site development plans have been revised. The original and revised figures are summarised in Table 1.1. This document updates the key analyses on water resources and demand for water, wastewater treatment capacity, and fluvial and surface water flooding. The updated housing figures have been submitted to STW for review using the same wastewater and sewerage template containing STW's asset values from 2014.




Figure 1.2 Growth per council ward

Ongoing completions and planning application approvals continually change the balance between committed and allocated data but the planning data as used within this update study is presented in Appendix A. Employment site data includes negative values. This reflects demolitions and so net figures are used in this report. Figure 1.1 maps the revised committed and allocated housing and employment sites. Figure 1.2 shows how the housing and employment development plans compare across the area in terms of commitments and allocations and overall numbers.

Figure 1.2 demonstrates the dominant influence of the sites which are already committed across the Council area. This chart is replicated in Section 3, annotated with the constraints identified within Section 2, and used to support the revised approach to phasing the development.

## 2. Revised Assessment

The original study identified the most significant constraints were related to the capacity of the wastewater treatment works and the sewerage network. Consequently this update focuses on the wastewater and sewerage capacity and the consequent strategy (i.e. the phasing recommendations) related to this aspect of the water cycle. Flood risk is a major issue and the original study identified a number of sites located in at risk flood zones (referred to as flood zones 2 and 3). Therefore the risk of fluvial flooding has been re-examined in the context of the new development plans. Surface water drainage was identified as an issue across the Telford and Wrekin area and this remains unchanged. However, the original locations identified as being particularly at risk from surface water (storm water) flooding have been re-examined to identify any new sites in those previously identified areas. Water supply is also an important issue but due to the limited constraints associated with the original development plans this is a more minor component of the update.

The outcomes of this update are presented in tables and maps which can easily be cross-referenced with the original report, following the same structure, and supported by explanatory text as required. This document identifies revised recommendations based on the revised housing figures. The scope of this update does not include progressing those recommendations.

As per the original study, the assessment uses a traffic light system to identify the potential scale or extent of constraints that the Council should be aware of:

No colour	No constraint or not assessed
	Low constraint: may cause no issues but require awareness.
	Medium constraint: may cause minor issues requiring investigation and / or action
	High constraint: likely to cause an issue requiring major action to resolve

### 2.1 Growth and demand in water resource zones

The major difference between this assessment and that completed in 2014 is the significant reduction in allocated homes across Telford & Wrekin. Figure 2.1 updates the original Figure 2.1 map of developments within the two water resource zones. The implications on demand per zone are identified in Table 2.1.

Under three alternative water efficiency scenarios (Table 2.1) the previous assessment concluded that allocated homes could drive between 2.39 Mld to 3.41Mld¹ extra demand for water. However, under the new development plans that is likely to drop to between 0.88Mld and 1.26Mld. This represents a significant reduction in an area where Severn Trent Water is pursuing options to secure the balance between demand and supply.



Section 2.5 of the original study reported that Severn Trent Water does not anticipate any significant capacity problems within the urban areas of its network, and that the company would address any issues that emerge by reinforcing its network. It did highlight development in the Rural Areas as likely to have a greater impact and that the supply network could require greater reinforcement to accommodate the increase in demand. Whilst the overall demand is reduced, the revised development plans have concentrated growth into a smaller number of locations, including within four wards in the Rural Area:

- Chetwynd Aston and Woodcote: new committed growth pattern could increase demand by a further 14,000 litres/day in addition to the original estimate of 101,000 litres/day;
- ► Ercall Magna: new committed growth pattern could increase demand by a further 73,000 litres/day in addition to the original estimate of 3,000 litres/day;
- ▶ Wrockwardine: new committed growth pattern could increase demand by a further 147,000 litres /day in addition to the original estimate of 9,000 litres/day. This is driven by a large strategic site with Resolution to Grant up to 470 new homes.

It is recommended that TWC continue to liaise with Severn Trent Water and ensure that the supply infrastructure for these committed developments is reflected in current infrastructure investments. However, from an allocations perspective development in the Rural Area is no longer an issue.

The revised allocations are likely to result in a considerable reduction in demand for water across most wards in the area. However, slightly increased concentrations in St. Georges and Priorslee, and Hollinswood & Randlay (both approximately 45 more homes) would drive slightly more pressure on the water supply infrastructure supplying those areas. Enhancements of this scale, in the context of the original relatively large scale developments (1150 and 250 respectively) are not expected to create significant problems for Severn Trent Water although the increases should be discussed as early as possible in the planning process.

## 2.2 Wastewater treatment and sewerage constraints

The capacity of the wastewater treatment works to accommodate additional growth was revealed by the original study to be the most significant constraining factor. The baseline situation at each wastewater treatment works has been updated using the same information from the original study (Severn Trent Water's confirmation of population equivalent actual demand draining to each WwTW as recorded in 2010) updated by applying the completions data from 2010 to 2014 to proxy assess the current 'population equivalent' demand. This has been examined against the 'population equivalent' maximum capacity as reported by Severn Trent Water. For this updated study, Severn Trent Water has confirmed the status of the discharge permits assigned to each treatment works. Only one small difference has been noted: a reduction from 2 to 1 mg/litre Phosphorus limit at Newport.

Table 2.3 compares the level of original and revised committed and allocated development per wastewater treatment works. It shows that overall reductions in housing growth will reduce the forecast pressure on all of the wastewater treatment works. The impact of the slight increase in development in St. Georges and Priorslee, and Hollinswood & Randlay is counteracted by the large scale reductions in other localities served by the same wastewater treatment works (Coalport WwTW). Four of the WwTW impacted originally (albeit to a very minor level) are now no longer affected: Ellerdine WwTW, High Ercall WwTW, Sugdon WwTW, and Crudgington WwTW.

Very small scale developments draining to and being served by Osbaston, Roden, Sambrook, and Waters Upton (combined total of 6) are excluded from further analysis. There are also a number of developments that are located a significant distance from the existing wastewater catchment area (total sum of properties: 19).

The original assessment showed that the Newport and Coalport wastewater treatment works were severely impacted in terms of constraint to accommodate committed development, and that all or much of the allocated development in sites that would drain to those treatment works would need to be delayed to allow time for Severn Trent Water to upgrade the works. The original study also highlighted the environmental water quality conditions (and objectives of the Water Framework Directive) and the capacity to further improve treatment technology as constraining factors. Table 2.4 updates the current situation in terms of the discharge consent limits and the existing demand being placed on each works that will be subject to



growth according to the revised development plans. Table 2.5 highlights the residual challenges to development, namely in the Newport, Coalport, and (much smaller) Waters Upton WwTW catchment areas.






Figure 2.3 WwTWs dry weather flow consent compared to existing and future dwelling numbers (large WwTWs)

Newport and Coalport wastewater treatment works remain under pressure from the proposed development. Resolving the issue in Newport remains critical as the treatment works only has capacity to serve up to 294 of the committed developments (homes and dwelling equivalent employment sites). This is illustrated in Figure 2.3. Newport is the smallest of the four major treatment works serving Telford and Wrekin and has limited capacity to increase the volume of wastewater it can treat. The primary constraint remains the capacity of the local water environment to receive higher volumes of effluent unless the quality of that effluent meets even more stringent requirements than already in place (see Table 2.4). The Council must continue to work with Severn Trent Water and the Environment Agency in its role as environmental regulator to find appropriate solutions to ensure environmental water quality objectives are met, to reduce the pressure on Severn Trent Water to invest in (potentially) disproportionately expensive (and energy intensive) treatment technology, and to support the committed growth in this area.

Residual capacity at the Rushmoor and Monkmoor WwTWs may offer some opportunities to reduce the pressure on Coalport and Newport and these should continue to be explored.

In addition to these major treatment works, four smaller works are also affected by the TWC growth plans. Edgmond WwTW is the largest, serving the Edgmond council ward area. Only very small scale development is planned in areas served by the smallest treatment works. The scale and type of action required to ensure both the developments and the environment can be sustained will be much smaller than that required to tackle the issues affecting Newport and Coalport, but these more minor issues will still need to be addressed.

Inevitably action is required to resolve the balance between demand for wastewater services and the existing capacity at Newport, Coalport, (and Waters Upton). Table 2.6 identifies the existing level of treatment being applied at these works (secondary level in all cases) suggesting that in order to continue complying with discharge permits whilst serving more customers treatment may possibly need to be increased to tertiary (information on treatment levels is available in Appendix C of the original study). Tertiary treatment typically demands significantly elevated energy consumption and requires more capital investment and operational expense. Appropriate solutions to these pressures should be determined via stakeholder dialogue.

The original study noted that in addition to the domestic-type use of water that employment sites will generate, and the associated 'dwelling equivalent' demand for water supply and wastewater services, some employment sites may also generate a 'trade effluent' demand for wastewater services. The nature of the allocated employment sites is not yet determined beyond the potential use-class designation but it is anticipated that there could be an element of food or beverage production. This could generate effluents with a relatively high biological component adding to the pressure on the treatment works. Table 2.7 updates the details of the allocated employment sites in

relation to the wastewater treatment works. Such development in North Telford (draining to Rushmoor) could be served by the residual headroom beyond that taken to support the housing growth. South Telford in contrast is not in the same situation and potential trade effluents could directly compete with the allocated housing development. If both types of development are required in parallel then this may drive a more staggered approach to housing development (see Section 3) or increase the urgency to resolve the capacity issues affecting Coalport WwTW.

The new housing is also used to review the drainage constraints: this is identified as under construction and committed (this is the sites that STW will use to assess capacity) plus the allocated (which is less definite and so not modelled by STW). Table 2.9 shows how the number of affected sewerage systems has been reduced, and within those how the range of potential impacts has shifted from predominantly 'Medium' to predominantly 'Low'.

## 2.3 Fluvial flood risks

## 2.3.1 Development sites at risk from fluvial flooding

The vast majority of allocated sites that were located in high risk flood zones 2 and 3 are no longer present in the new plan. With the exception of two sites all the new 'allocated' sites are in flood zone 1. A flood risk 3 zone runs right through the middle of the southern part of the 'Land at the Hem' site. The northern part of the site is clear of flood risk. SHLAA Site 386 also has a flood risk 3 zone running through the middle of the site. This does not necessarily mean that these developments should not take place but the housing design, site layout, including access, should be sensitive to the flood plain within the site. Development must not be allowed to occur within the flood plain, or in areas likely to inhibit the performance of the flood plain to hold water during flood events.

#### 2.3.2 Risks to development sites from surface water flooding

In the original study TWC provided detailed information on known surface water and drainage issues affecting the development sites. The scope of this update did not include replicating this information and so has focussed on comparing the location of the original and the revised list of allocated sites. 353 new sites have been introduced in the revised development data. These cannot be directly compared to the original study but are illustrated in Figure 2.5 and listed in Table 2.12. These are necessarily excluded from the re-assessment as presented in Table 2.11).



## 2.4 Overview of constraints per area

The total number of developments is much reduced from the original study in 2014, with the number of allocated dwellings reduced by 4.616 from a maximum of 8115 to a maximum of 3449. This has reduced the pressure on the water services and environmental water infrastructure. However, there remain a smaller number of constraints that will require action in order to support the revised growth plans, particularly given the volume of committed developments.

# 3. Strategy recommendations – update

This section updates the key messages from the original chapter 5. The original study recommended a phased approach to enable TWC to meet its 5 year housing requirements by prioritising those sites which are least constrained, and planning well in advance for the sites that likely need to pushed back to give time for the supporting infrastructure to be developed. The scale of the constraints is now lower but phasing is still required.

## 3.1 Proposed phasing of development

It is clear from Table 3.1 that there are a number of sites, particularly being served by the constrained Coalport WwTW which are at risk from multiple constraints. By identifying these it is possible to recommend individual sites which may most effectively be delayed until later in the planning horizon to allow multiple constraints to be resolved.

This section clarifies the implications of those constraints with regards to development numbers in specific areas, updates the improvements that will be required, and the actions that TWC can take to work with its partners, the Environment Agency and Severn Trent Water to effectively plan and implement development that will be sustainable.






Figure 3.1 Summary of constraining factors per development area

Of the constrained areas served by Coalport WwTW it is Lilleshall, Donnington, and Muxton; St. Georges & Priorslee; and Stirchley and Brookside which require the most multiple issues to be resolved. Potentially, it is the Chetwynd Aston & Woodcote area of the Newport WwTW catchment area which has the most issues. This could form the basis of decisions on which sites to delay (from a water cycle infrastructure perspective).

In the short term, i.e. at least within the next five years TWC should be able to deliver its housing requirement target through the delivery of committed housing, and by focusing allocated development in the areas served by the Rushmoor WwTW. Development could also take place within the Coalport catchment. The Environment Agency is currently modelling the potential impact of growth in this catchment on the water quality of the receiving waters. The results of the modelling should be used to support decisions on the phasing and locating of development. In advance of those results the Council may wish to consider the following actions:

 TWC and Severn Trent Water urgently need to discuss the implications of the committed developments in the Newport and Waters Upton WwTW catchments. As committed sites are taken through to completion TWC should relay this information to Severn Trent Water. No change from the original study.

- 2. The next priority is to confirm that the already committed developments within the Rushmoor and Coalport WwTW catchments can be adequately served by the sewerage system. TWC should provide an up to date list and map of committed sites with expected dwelling numbers to enable Severn Trent Water to assess the sewerage situation of these confirmed sites. Information from Severn Trent Water suggests the level of constraint will be low to medium. This is still an issue but to a lesser degree than in the original study. The main issue is potentially the number of committed sites (largely unchanged) and the potential impact in St. Georges and Priorslee.
- 3. In parallel with tasks 1 and 2, TWC is urged to prepare guidance for developers on the drainage requirements that planning applications will need to comply with. Surface water flooding and drainage is an issue across Telford & Wrekin and so, as the Lead Local Flood Authority and SUDs Approval Body, TWC needs to be prepared. The guidance should also explain where developers can access technical information on Sustainable Drainage techniques, but also the process that will be in place to examine the credibility of drainage plans and the subsequent developments. This advice is unchanged from the original study but attention may focus on the smaller number of areas identified as medium constrained. The study has also highlighted the large number of new sites for which no surface water drainage information has been available to this study.

#### Proposed phasing:

Phase 1: Wellington and Wrockwardine Wood and Trench are the least constrained areas and so may offer scope for bringing development forward (**combined maximum of 338 allocated dwellings**). As soon as TWC is able to confirm that sites will be developed this information needs to be given to Severn Trent Water to assess the potential need for sewerage infrastructure works in the area. Sewerage constraints are not expected to be significant, and should not delay development if sufficient notice is provided. TWC and Severn Trent Water are encouraged to discuss with developers opportunities to dovetail sewerage infrastructure with the groundworks stage of construction, if necessary.

Phase 2:The next sites with limited constraints beyond medium surface water flooding are the Land at Holyhead (St. Georges and Priorslee), Lawley West, Land at Muxton, and the portion of the Land North of Priorslee Roundabout served by Rushmoor WwTW (all the whole site if it will drain to Rushmoor rather than Coalport WwTW). These sites offer a combined maximum of 1055 (or 1090 if all of the Priorslee Roundabout land is developed to drain to Rushmoor). Arguably some of these sites could be delivered in parallel with Phase 1 on provision of adequate surface water management actions.

Approximately a third of the allocated sites in the Coalport WwTW can be served by the existing works. Potential candidates based on the combined level of constraints are: 240 dwellings in Great Dawley; 54 dwellings in Madeley, 146 dwellings in The Gorge, and the 70 dwellings in Lawley and Overdale. **These sites offer a combined maximum of 510 dwellings.** 

In parallel with these residential developments the Council may wish to integrate development of the employment sites. Sites E1 to E17, and E28 could be supported by the existing works. However, if any of these sites require a trade effluent discharge to the sewer this should be brought to Severn Trent Water's attention as early as possible.

Phase 3: Actions to increase the capacity at Coalport WwTW could be planned for implementation during the water industry Asset Management Period 7 (AMP7: 2020/21 to 2024/25). By delaying Phase 1 and Phase 2 until after the committed development period, implementation could be delayed until the end of AMP7 whilst maintaining the annual housing targets (Figure 3.2). During this time it is recommended that action is taken to reduce the impact of development on surface water flooding, and to increase the resilience of developments fluvial flooding. Once these

constraints have been addressed the remaining development sites in the catchment could be brought online: Land at the Hem (300 dwellings), the Coalport side of the Priorslee Roundabout and Holyhead Road developments (55 dwellings), and the former Swan Centre (21). **These sites offer a combined maximum of 375 dwellings.** 

Similarly, in parallel or subsequent to the final Coalport housing sites being brought online, the opportunity could be available to introduce the remaining Coalport catchment allocated employment sites (E18 to E26).

Phase 4: Development in Newport is constrained by almost every aspect of the water environment and water services infrastructure and allocated housing in this area should be at the bottom of the priority list. The 120 dwellings in Newport, and the employment site in Chetwynd Aston & Woodcote (E27) may form the latter stages of the Council's development plans. Works needed to support any growth in this area include:

- Quantification of the additional Dry Weather Flow demand expected to be generated (Severn Trent Water)
- Water quality modelling to determine the quality conditions for an amended discharge permit (Environment Agency);
- Newport WwTW needs to be upgraded to meet the conditions of the future discharge permit (this could be particularly challenging as the Environment Agency is concerned about the level of treatment technology that is available to deliver water quality to the standard that might be required);
- ▶ Plans to ensure that development will not increase surface water runoff into the Strine IDB system (ideally plans that will mitigate existing problems);
- Investigations into the groundwater level beneath Newport to better understand the risk to property from groundwater flooding;
- ► Fluvial flood risks from the Humber Brook and the Moorfield Brook need to be better understood and development sites planned taking the results into consideration.

Severn Trent Water is planning some capital maintenance at Newport WwTW with in AMP6 and it is possible that will include provision of additional capacity at the same time. This could help to resolve the problem of the existing committed developments exceeding capacity at Newport WwTW. It is possible that the works to be undertaken by Severn Trent Water could resolve the whole exceedance problem, at which point the Newport developments could be brought on line. However, at this stage, it is recommended that the Newport developments form the latter stage of development in Telford & Wrekin.

## 3.2 Growth rate

Housing growth is not expected to exceed 1000 per annum and as there are over 10,900 committed sites yet to be completed it is expected that starting from 2015/16 as year 1, the committed sites will dominate the building phase for the first six years up to 2020/21. On this basis TWC and Severn Trent Water have more time to plan the delivery of the allocated sites and required infrastructure, taking the opportunity to incorporate development plans into the 2019 and 2024 Water Resource Management Plans. A suggested timeline is presented in Figure 5.1 which can be cross-referenced against the spatial phasing map in Figure 3.2.

The various developments have been grouped by parish into 'phases' which are colour coded for representation in Figure 3.2. The coding is illustrated in Table 3.1





Figure 3.3 Housing delivery forecast – based on water cycle constraints

According to this proposed phasing approach the initial committed growth followed by completion of the allocated housing and employment sites could deliver a growth rate as illustrated by the chart Figure 3.2. This can be cross-referenced against the spatial phasing map in Figure 3.3.

The developments currently under construction are expected to complete within the next three years. TWC has provided a market-intelligence based projection of which committed sites are expected to be developed per annum across the timeline to 2030/31. This assessment excludes 738 committed dwellings (or dwelling equivalents) from within the GIS dataset. This residual component has been integrated into the potential phasing assessment on the basis of equal numbers between 2020/21 and 2030/31 (prior to this the first five years of the planning horizon are forecast to deliver a minimum of 880 per annum). Figure 3.2 illustrates how the development timeline would appear if the Market-Intelligence Based Projection is realised. This is in contrast to Figure 3.3 which illustrates how the timeline could look if it is developed in line with the phasing recommended to adjust to the water cycle constraints.

Under this plan, developments that have been recommended for delivery later in the planning period (i.e. Phase 3 and Phase 4 developments) occur as early as Year 6. This includes developments which are constrained by wastewater treatment capacity, flood risk, surface water management issues, and potentially supply/sewerage network issues. Conversely, the Market Intelligence suggests less appetite to bring forward Phase 1 sites (i.e. in Wellington and Wrockwardine Wood & Trench) with some sites delayed until year 19. The same sites, as allocated into phasing by the water cycle study are illustrated in Figure 3.3.

Figure 3.3 is simply a suggestion illustrating the comparative stages for development. Actual growth rates are likely to be influenced by other factors external to this water cycle study. Developments may be delayed further if annual build rates are lower than in this suggestion. However, there are potential conflicts between the commercial drivers for growth, and the environmental and infrastructure capacity to support growth spatially.

Key points to note are the requirements to delay the Phase 3 Coalport WwTW and the Newport WwTW catchment development sites until at least AMP7 (commences 2019/20) to allow Severn Trent Water time to plan and implement the necessary investment.



The 'Actions and Duties' set out in the original report (Section 5.4), and the Funding Considerations (section 5.5) do not change as a result of the updated development data. The original study suggested a range of policy recommendations:

- Water efficiency: requirements in residential and commercial development applications. It was recommended that TWC supports STW in its efforts to manage demand for water from existing and new build homes and commercial properties. Despite the reduced allocation this is still a valid policy in line with the Government's expectations on the water industry to control demand, and sustainability principles relating to water abstraction, and the energy and carbon implications of abstracting, treating, and distributing water.
- ➤ Sustainable drainage requirements: The original study advised TWC to develop guidance for developers on planning and implementing appropriate SUDs schemes within developments. Surface water flooding remains an issue across Telford and Wrekin due to the geology and topography of the area and all new developments are potentially at risk of flooding, or at risk of exacerbating existing surface water flooding problems. The recommendation to develop and provide appropriate guidance remains valid.
