

Borough of Telford & Wrekin

The Council has made the Borough of Telford and Wrekin, Footpath 79, Footpath 80, Footpath 81 Footpath 103, Severn Valley Way, Strethill Road/Bridleway 69, Footpath 72, Bridleway, 78/Strethill Road, Restricted Byway 78/Strethill Road, Footpath 10, Bridleway 71 and Footpath 74, Ironbridge (Temporary Prohibition of Pedestrians) Order 2021 under the Road Traffic Regulation Act 1984, in order to undertake Development works. The order becomes operational from the 1/9/21. The following footpaths are affected: along FOOTPATH 79 from its jcn with Buildwas Rd to the jcn with FOOTPATH 80, Footpath 81 from its jcn with The Wharfage to its jcn with Footpath 80, FOOTPATH 80 from its jcn with Footpath 81 to its jcn with Footpath 79 and its jcn with Buildwas Road., FOOTPATH 103 from its jcn with Bridge Rd to its jcn with the Severn Valley Way., SEVERN VALLEY WAY from its jcn with Bridge Rd to its jcn with Footpath 103 and its jcn with the Borough boundary, STRETHILL ROAD/BRIDLEWAY 69 from its jcn with Buildwas Rd to its Jcn with Bridleway 71, Footpath 72, and Bridleway 78/Strethill Rd. FOOTPATH 72 from its jnc with the Buildwas Rd to its jcn with Bridleway 69, Bridleway 71, and Bridleway 78/Strethill Rd. BRIDLEWAY 78/STRETHILL RD – from its jcn with Strethill Rd/Bridleway 69, Footpath 72, Bridleway 71 to its jcn with Restricted Byway78/Strethill Rd. RESTRICTED BYWAY 78/STRETHILL RD from its jcn with Bridleway 78/Strethill Rd to its jcn with Footpath 10. FOOTPATH 10 from its jcn with Restricted Byway 78/Strethill Rd to its jcn with Coach Rd. BRIDLEWAY 71 from its jcn with Strethill Rd/Bridleway 69, Footpath 72, and Bridleway 78/Strethill Rd to its jcn with Footpath 74 and its jcn with Coalbrookdale Rd.FOOTPATH 74 from its jcn with the Buildwas Rd to its jcn with Bridleway 71 and its jcn with the Coalbrookdale Road. The maximum duration is 6 month, but the works will take place for a duration of 1 day between 1/9/21 and 30/9/21.
