**TWC/2020/0227** – 8 The Wharfage, Ironbridge & 6 Severn Bank, Ironbridge – Erection of a first floor extension to the rear and 1no. roof light. Resurfacing and guarding of existing shared roof terrace and block up of existing first floor level rear door. Replacement of all windows and doors and proposed roof repair works. Installation of French doors to 6 Severn Bank for access to proposed roof terrace (Full Planning Application)

**TWC/2020/0228** – 8 The Wharfage, Ironbridge & 6 Severn Bank, Ironbridge – Erection of a first floor extension to the rear incorporating creation of a new internal staircase and 1no. roof light. Removal and relocation of internal walls, repairs to floor structures including tiles on ground floor. Re-plastering of internal walls and repair and replacement of external front elevation rendering. Resurfacing and guarding of existing shared roof terrace and block up of existing first floor level rear door. Replacement of all windows and doors, proposed roof repair works and repair and maintenance of existing vaulted space and external WC. Installation of French doors to 6 Severn Bank for access to proposed roof terrace (Listed Building Application)

**TWC/2020/0231 & TWC/2020/0232** – Golden Ball Inn, Newbridge Road, Ironbridge – Replacement and installation of 4no. timber casement windows (Full Planning & Listed Building Application) (Retrospective)

**TWC/2020/0236** – Land adjacent 82A Limekiln Lane, Lilleshall – Outline application for the erection of 2no. dwellings with all matters reserved

**TWC/2020/0237** – 14 New Street, Wellington – Installation of 1no. static externally illuminated fascia sign and 1no. static externally illuminated projecting sign

**TWC/2020/0238** – Hillside House, Strethill Road, Coalbrookdale – Erection of a front boundary wall, 2no. brick pillars, galvanised railings and double and pedestrian gates

**TWC/2020/0240** – 27 Church Hill, Ironbridge – Repairs and replacement to side hall roof including the change of pitched roof to flat roof with new parapet and replacement and installation of 2no. roof lights and 3no. doors (Full Planning Application)

**TWC/2020/0241** – 27 Church Hill, Ironbridge – Repairs and replacement to side hall roof including the change of pitched roof to flat roof with new parapet, replacement and installation of 2no. roof lights and 3no. doors, replacement of external paving and damp proof plastering. Installation of internal walls and reconfiguration of internal layout (Listed Building Application)
