- Bagley Drive, Wellington (the north-west side) from its junction with Marton Drive in a south westerly direction for a distance
 of 11m
- Bagley Drive, Wellington (the south-east side) from its junction with Marton Drive in a south westerly direction for a distance of 17m
- Crescent Road, Wellington (the west side) from a point 15m north of its junction with Vineyard Road for a distance of 50m in a northerly direction
- 4. Marton Drive, Wellington (the east side) from a point 9.5m south of Clunbery Road in a south east direction for a distance of
