**Bridleway Addition (Wrekin Hill) Parish of Little Wenlock and Parish of Wrockwardine Modification Order No. 9 2023**

**Footpath 74 Upgrade to Bridleway (Wrekin Hill) Parish of Little Wenlock Modification Order No. 10 2023**

**Footpath 67 Upgrade to Bridleway (Wrekin Hill) Parish of Little Wenlock Modification Order No. 11 2023**

**Footpath 72 Upgrade to Bridleway (Wrekin Hill) Parish of Little Wenlock Modification Order No. 12 2023**

The above Orders, made on 20<sup>th</sup> July 2023 under Section 53(2)(b) of the Wildlife and Countryside Act 1981, if confirmed as made, will modify the definitive map and statement for the area by adding and upgrading to a bridleway the following public rights of way:

**Bridleway Addition** commencing at Ordnance Survey Grid Reference (OSGR) SJ 62515 09033 on the highway named Wrekin Course running in a South East by South direction across an open field on an earth surface with an approximate width of 2.5 metres for approximately 171 metres towards the woodland at OSGR SJ 62617 08911 continuing in the same direction for approximately 244 metres through the woodland to terminate on public right of way presently shown as Footpath 75 at OSGR SJ 62782 08723.

**Footpath 74** commencing on the junction with a public right of way presently shown as Footpath 75 at Ordnance Survey Grid Reference (OSGR) SJ 63224 09180, the route being a stone/earth path having a width of 2.5 metres travels in a general South East by South direction for approximately 198 metres then loops round for approximately 193 metres and continues in a general East North East direction for approximately 292 metres to the junction with public right of way presently shown as Footpath 72 at OSGR SJ 63694 09088 and continues in a general South direction for approximately 268 metres to terminate at the junction with public rights of way presently shown as Footpath 69 and Bridleway 64 at OSGR SJ 63683 08847.

**Footpath 67** commencing on the junction with a public right of way presently shown as Footpath 66 at Ordnance Survey Grid Reference (OSGR) SJ 63756 09015, the route being an earth path having an approximate width of 2.5 metres travels in a general East South East direction for approximately 129 metres to terminate at the junction with Bridleway 63 at OSGR 63846 08977.

**Footpath 72** commencing at Ordnance Survey Grid Reference (OSGR) SJ 62733 08029 on the Shropshire border adjoining the public right of way presently shown as Footpath 18, the route being a stone/earth path having a width of 2.5 metres

continues in a general North East direction for approximately 1418 metres to terminate at the junction with the rights of way presently having a status of Footpath 74 and Footpath 69 at OSGR SJ 63690 09068.
